Introduction to REMAP

Lizzie's Story...

Lizzie has Cerebral Palsy, which means she cannot use her hands for tasks like painting. Lizzie likes to participate in art therapy sessions but being in a wheelchair makes it difficult for her to paint on a commercially available easel.

A device was made for her some time ago which allows a paintbrush to be attached to a cycling helmet. However, this was difficult for her to use, as it kept slipping and was uncomfortable to wear. Her painting therapist Simon had to hold her painting attached to a board so she could reach it.

After discussions with Simon, a new device was created for Lizzie by Volunteer Engineer, Peter. The device holds her paintbrush firmly to an adjustable head harness, giving her better control over what she paints. Peter also adapted her easel to lean forwards and clamp onto a table, helping to aid Lizzie's posture.

The two adapted devices enable Lizzie to now paint for longer in comfort. She also has more direct control over the process, becoming less reliant on Simon to help her with her beautiful creations.

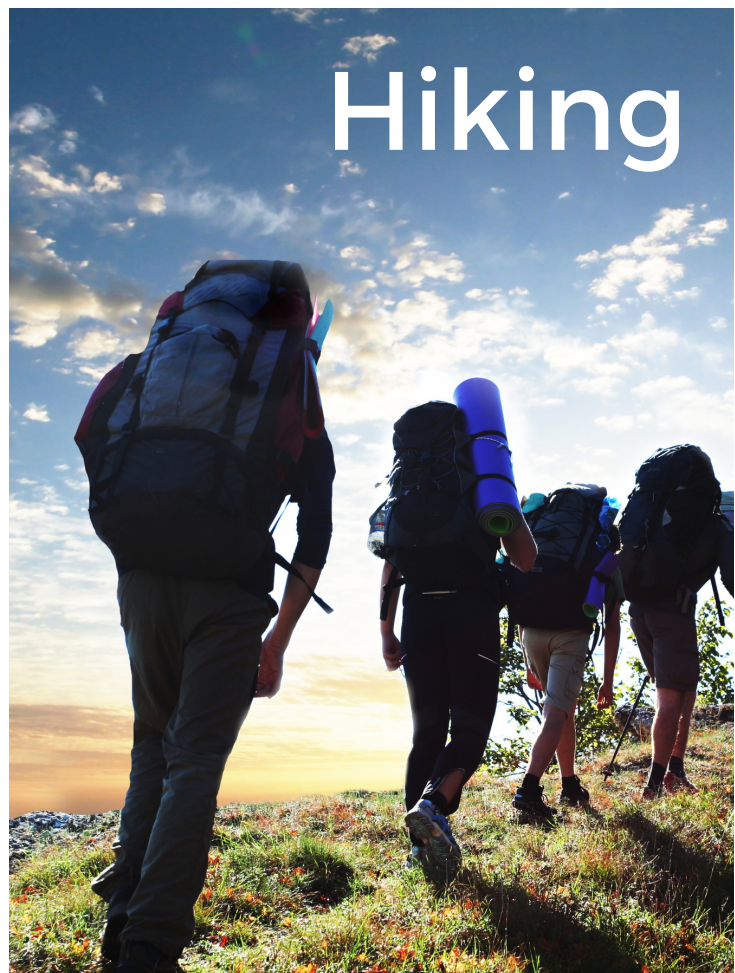

Tips To Maximise Sponsorship And Donations

Social Media:

- Make sure to maximise the power of social media, and publish your fundraising on all of your channels.
- The power of a thank you. Actively thank people as they donate, tag them on your Instagram stories or write a post about them,
- Time when you are posting, try at the end of the month around payday.
- Link your fundraising page to your socials so it automatically updates.
- Get your friends and family to share your link.

Fundraising Page:

- If you are taking part in an active challenge remember to link your Strava to your fundraising page. This posts all of your activity and pictures that you have uploaded on the app.
- Make sure that you get across your story, and let people know why you are fundraising for us and why they should support you.
- Add a great picture, the more you fill in and are active on your page, the better!

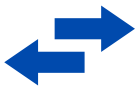
Get Creative:

- Organise a sweepstake with your friends and work colleagues, and get them to guess what time you will finish your challenge in, with the winner getting a small prize.
- Draw on your own skills, offer a training session, such as a workout or a demonstration of a hobby and ask for donations.
- Ask your workplace to match fund your fundraising.
- Go live, stream yourself online, hit targets for each one reached, and do a challenge.
- Make sure once you have completed the event that you follow up with an update, use this as a last chance to get more donations in.
